 - (vi) All the expenses to be incurred as to the course will be borne by the "Study for specificity of netB-harboursing Clostridium perfringens in avian, bovine and other mammalian species and the relationship between NetB and atypical Beta2 toxins in pathogenicity of avian necrotic enteritis" Project, Graduate School of Life and Environmental Sciences, Osaka Prefecture University, Japan.
 - (vii) The officer mentioned above will be considered to be placed in the post of Leave-Reserve during the permitted period.
