

 - (iii) The course participant will draw his pay and allowances from the Government of Bangladesh as per Government rules.
 - (iv) After completion of his study and return to the country he will have to join his service and submit a report to the Ministry.
 - (v) No application will be allowed to extend the course period.
 - (vi) All the expenses to be incurred as to the course will be borne by University Malaysia Terengganu (UMT), Malaysia.
 - (vii) The officer mentioned above will be considered to be placed in the post of Leave-Reserve during the permitted period.
3. The previous Government order issued vide memo no:33.02.0000.109.19.017.13.69 dated: 16/02/2016 hereby cancelled.
4. This order is issued with the approval of the competent authority.


