 - (iv) After completion of his study and return to the country he will have to submit a report to the Ministry.
 - (v) He will have to join his service after the completion of his study.
 - (vi) All the expenses to be incurred as to the course will be borne by the Australia Awards Scholarship.
 - (vii) The officer mentioned above will be considered to be placed in the post of Leave-Reserve during the permitted period.
3. This order is issued with the approval of the competent authority.


